Offences

Individual Demerits

Offence	Points Issued
Late for any official meetings after Expose II (e.g. AoM, Budget check)	1 demerit point
Attire issues (socks, shoes, hair, uniform, collar pin, inappropriate banner-painting attire)	1 demerit point
Late submissions* (of leave – within 24 hours)	2 demerit points
School demerits	2 demerit points each
Absence from any official meeting without reason	3 demerit points
Being disrespectful to seniors and teachers	1 demerit point

** We would not entertain any form of late submissions.*

For AOM 1, groups with late submissions will be issued 2 demerit points and they will have to submit their proposal 1 day after the deadline by 1700h or the proposal will be fully rejected.

For AOM 2, groups with late submissions will be issued 2 demerit points and candidates will not be allowed to showcase that particular gimmick at all.

For the IoC Proposal, groups with late submissions will be issued 2 demerit points and candidates will have to submit their proposal 1 day after the deadline by 1700h or the proposal will be fully rejected and candidates will not be allowed to present anything for IoC except for their name and class.

Group Demerits

Offence	Points Issued
Overspending/ bursting Budget (and further confiscation of materials used until the group adheres to the budget limit)	2 demerit points
Breaking of campaigning rules (eg. Putting blu-tack on walls, not adhering to online campaigning times etc.)	1 demerit point
Loss of receipts for Budget Check	1 demerit point per receipt
Using rejected materials for campaigning	3 demerit points + 1 minute taken off overall group presentation time (regardless of demerit points) Respective materials to be removed with immediate effect
Making changes to materials after AOM II	3 demerit points + 1 minute taken off overall group presentation time (regardless of demerit points) Respective materials to be removed with immediate effect

Punishments

To ensure that the demerits system is not misused as a CHANCE system, punishments will be introduced for respective number of demerits accumulated.

The punishment system is as proposed:

Individual Demerits

Number of Points	Punishment
3 demerit points	20 seconds taken away from individual IoC presentation time.
4 demerit points	30 seconds taken away from individual IoC presentation time
5 demerit points and above	Meeting with teachers and EleCo ICs (Faculty ICs and Chair/Sec-Treas) for explanation Punishment up to discretion of the EleCo ICs after meeting

Group Demerits

Number of Points	Punishment
5-6 demerit points	1 minute of group presentation time taken away
7-8 demerit points	1 minute 30 seconds of group presentation time taken away
9-10 demerits points	2 minutes of group presentation time taken away
11 demerits points and above	Meeting with teachers and EleCo ICs (Faculty ICs and Chair/Sec-Treas) for explanation Punishment up to discretion of the EleCo ICs after meeting
